Ram has tried to stop his father from beating his mother. Ram's mother has been calling Ram a "no good" and tells him that he is like his father since Ram prefers not to go to school and to go out with his friends. Ram does not like school because the teachers call him a dunce. He does not have money for clothes and sometimes he is hungry. His mother has two younger children and Ram. Ram says that his mother only looks after the younger children and not him. Ram drank poison because his mother accused him of stealing some money. He says he did not steal the money and he might as well be dead.
